WHY THE TIER 1 (ENTREPRENEUR) MIGRANT ROUTE?



Invest Only £200,000

You are only required to invest £200,000 into a UK business, far less than the £2million required for the Tier 1 (Investor) route.

Option to obtain settlement after 3 years if your business is successful

If your business creates ten new full-time jobs for settled persons in the UK, or if the business creates an income from business activity of at least £5million.

ENTREPRENEUR MIGRANT

Bring your family to the UK

You are allowed to bring dependants (children under 18 years of age, or your husband, wife, civil partner, or unmarried or same-sex partner) with you to the UK. Your children entering the UK as your dependants are entitled to the same free education as British children.

Obtain settlement after 5 years

You are allowed to remain outside of the UK for a maximum of 180 days in any 12 month period without losing your right to apply for Indefinite Leave to Remain/Permanent Residence (PR).

TIER 1 (ENTREPRENEUR) MIGRANT REQUIREMENTS



1. INITIAL APPLICATION

(3 years plus 4 months for Entry Clearance, 3 years for applications made inside of the UK)

- You must have access to at least £200,000;
- You are required to provide evidence that you speak, communicate and understand English language to a certain level (IELTS General Level 4);
- You need to provide evidence confirming that yourself and any dependants meet the maintenance requirement;
- You need to show evidence that you meet the 'genuine entrepreneur' test.

2. EXTENSION APPLICATION (2 years visa)

- By providing evidence that the applicant has invested, not less than £200,000;
- By providing evidence that the applicant has registered with HMRC as a self-employed person or registered a new business in which he is a director or registered as a director of an existing business;
- By providing evidence that the applicant is engaged in business activity at the time of this application for leave to remain;
- By providing evidence that this business has created two full-time positions for persons settled in the UK;
- You need to show evidence that you meet the 'genuine entrepreneur' test.

3. SETTLEMENT (after 5 years)

- Those who have completed five years in a **Tier1 (Entrepreneur)** visa will be able to apply for **Indefinite Leave to Remain** one month before completing their five years;
- **Accelerated Settlement - Tier1 (Entrepreneur)** migrants will also be eligible for accelerated settlement upon completion of 3 years' time, provided they fulfil one of the following requirements:
 - Creation of 10 full-time positions for resident workers for at least 12 months; or
 - If the business creates an income from business activity of at least £5million;
- Applicants for **ILR** under the accelerated route must also prove that they have invested the funds;
- You need to show evidence that you meet the 'genuine entrepreneur' test.
